With reference to your email please note that the Commission neither has registered with it an entity called 'PAMI' or 'PAMI Colleges' nor does it recognize any such entity as an official representative of the individual registered medical and dental colleges. Until such time as any individual college inform the Commission in writing that it will be represented officially in all matters by any entity such as PAMI, unfortunately, the Commission is not in a position to communicate with yourself in any capacity.

The Commission at all times welcomes dialogue with the medical and dental colleges registered with it, as and when it receives communication from any of the colleges directly.

As to the conference scheduled for 25th and 26th June 2021 for all registered public and private colleges neither has PAMI been invited to the same and nor has any college submitted any concerns as to any specific provision of the PMC Medical and Dental Undergraduate Education (Admission, Curriculum and Conduct) Regulations 2021. The same remain in force and will be enforced in letter and spirit as they seek to enforce transparent and merit-based admissions to medical and dental colleges across Pakistan keeping in perspective the interests of aspiring students.

Dear Sir,

This is to kindly inform you that PAMI is the main stake holder in admissions in medical and dental colleges and the PMC made “ 2022- Admissions in medical & dental colleges in Pakistan- Regulations” have a direct effect on the admissions in private colleges.

The PAMI in its meeting on 19th June 2021 had severe reservation on the PMC made 2022- Admissions in medical & dental colleges in Pakistan- Regulations” as the PAMI thinks that there are flaws in the text of regulations as well as in its scope and these flaws can be removed by mutual consultation only.

The PAMI requests that implementation on the “ 2022- Admissions in medical & dental colleges in Pakistan- Regulations” may kindly be deferred till a consensus is reached between PAMI and PMC so that that there is no violation of the PMC Act specially its section 18.

Hence, it is requested that the planned moot on 26th June 2021 should be postponed or held only after the PMC gives PAMI a chance to submit its written suggestions by a set short date which can be communicated to PAMI by PMC so that PAMI can send its suggestions / amendments to PMC by that date .

The PAMI colleges have decided that PAMI suggestions will be submitted in best national interest and the PMC regulations have to be amended and they will become workable in the best spirit of law and in national interest.

The PAMI colleges have decided not to attend the PMC meetings and the planned moot on 26th June 2021 until the suggestions of PAMI are given due consideration and are incorporated in the regulations .

PMC may consider this request in the best national interest.
